## 1. Objective

The objective of this MOU is to express the willingness of both colleges to engage in an effort to promote the level of academic atmosphere and activities in the departments of Education, Sabang Sajanikanta Mahavidyalaya & Vidyasagar Teachers' Training college.

A certificate course on **Modern Trends of teaching Methodology & Application** will be introduced under this MOU
between the departments of Education, Sabang Sajanikanta
Mahavidyalaya & Vidyasagar Teachers' Training college.

The departments of both colleges will enhance the quality in the field of teaching and research by sharing and exchanging its faculties and students of UG & Training level.

Both colleges agrees to provide their academic and technical assistance to carry out activities which will improve the academic atmosphere, academic activities, extension activities, academic collaboration, academic quality, student's progression, cultural atmosphere, and research atmosphere in the said institutions as well as the quality enhancement of both of the colleges by this collaboration and exchange programme.

## 2. General Terms of MOU

**A. Duration of MOU**: This MOU will be effective from the date of the agreement and will have an initial duration of two years. There is also a provision to extend the MOU.

- **C. Technical and Financial Support:** Technical& financial support for each activity will be provided by the concerned college.
- **D. Confidentiality:** At any time, after executing the activities of this MOU each college agrees that none of the colleges will disclose any information in related to these activities without the consent of both colleges.
- **E. Termination of MOU:** The partnership covered by this MOU will be terminated upon the completion of the agreed period of two years. The agreement may also be terminated with a written one-month notice from both sides.
- **F. Extension of Agreement:** The MOU may be extended according to the willingness of both colleges with prior intimation and permission of the authorities one month before the end of the existing MOU.
- **G. Communications:** All notices, documents and any other communication under this agreement in connection herewith will be in written form and sent to the postal address, email, or fax of the concerned college. Any notice will be effective from the date on which it is signed.
- **H. Addendum:** Any Addendum to this MOU will be in written form and signed by authorities of both colleges.

#### I. Programme Consult:

The colleges in MOU will be initiating faculty exchange as and when required in consultation with the concerned department. The purpose is to promote academic exchange Principal 13-8-2-1 Vidyasagar Teathers Training College Paschim Medinipur

Some certificate courses for each year may be introduced by the concerned department of a college with the prior consultation of the corresponding department of another college.

J. Venue of the Programme: Each college will organize any programme on their own premises in collaboration with other colleges by using their own assistance and resource. Third place may be treated as a venue of any programme by the consultation of the two colleges with the financial sharing.

## 3. Other Provisions

- **A.** Initially Faculty exchange for special lecture, seminar class and other programme will be made at departmental level with the consultation of specific faculty and the department.
- **B.** Department of Education, Sabang Sajanikanta Mahavidyalaya will be engaged to conduct the programme on certificate course. This type of exchange programme will be continued for any other departments by the consultation of the authorities of the two colleges.
- **C.** This type of exchange may be implemented in the field of cultural programmes and sports activities.
- **D.** Students and teachers may visit and use the departmental library as well as the central library.

- **E.** Students, teachers, resource persons, and participants may use the resources of reverse college during the exchange and extension activities also.
- **F.** Teaching may be shared with the students due to prior permission of the authorities with a proper Identity Card.
- **G.** Both parties assume that this agreement does not go against the rules and regulations of the Government of WB & UGC.

The terms and provisions in this MOU also apply to any subsequent Addendum to this agreement.

The parties executed this MOU on 13th August 2021and will remain valid up to two years.
