- (iii) Organize seminar, conferences, workshops, symposiums jointly on relevant topics on Education, Psychology, Environment Education, Teacher Education, ELT etc.

The general purpose of this agreement is to establish specific educational relations and cooperation between the two participating institutions in order to promote academic linkages and to enrich the skill development in teaching-learning techniques and human resource management.

It will remain valid till any of the parties chooses to withdraw from the linkage.

Any notice or other communication under this agreement shall be given in writing and delivered by hand, sent by post, facsimiled transmission or e-mail.

This agreement constitutes the agreement in principle to proceed and workout more detailed modalities to operationalize the same between the parties. No amendments consent or waiver of terms of this agreement shall bind either party unless in writing and signed by both parties.

The MOU will be valid for 5 years.
