The Agreement

This Memorandum of Understanding,.....2022 between Vidyasagar Teachers' Training College, Midnapore, West Bengal, (First Party) and the Global Technical Training Institute, Midnapore (Second Party) will serve as a guiding document for use by students and administrators of both institutions in understanding the academic relationship between the Computer Technology programmes and skill enhancement.

Objectives

- To conduct practical trainings on Entrepreneurship Development
- To generate text content for upgrading self-employment opportunities for teacher trainees
- To assist the trainees in enhancing ICT based capabilities for developing teaching learning situation.
- To provide opportunities for future placement of trainee teachers.

CO-OPERATION

1.1 Both parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations. The parties shall keep each other informed of potential opportunities and share all information that may be relevant to secure additional opportunities for one another.

1.2 The co-operation between First Party and Second Party will facilitate effective utilization of the intellectual capabilities of the Second Party providing significant inputs to them in developing ICT skills among the trainee teachers of the First Party.

SCOPE OF THE MOU

- Both parties believe that close co-operation between the two would be beneficial to the student community and enhance the skills and knowledge of the beneficiaries of the First Party.
- The Second Party will train the students of the First Party on the emerging technologies in order to bridge the gap in skill and make them ready for industry.
- The Second Party will extend the necessary support to deliver training (Theory & Practical) trainees of the First Party on the technology trends.
- The Second Party will actively engage to help the delivery of the training and placement of students of the First Party into internships /jobs.

VALIDITY

- The validity of the agreement is three years from the date of agreement which needs to be renewed every year.
- In the event of termination, both parties have to discharge their obligations.
- Any dispute will be settled in the Midnapore Court only where the Global Technical Training Institute, Midnapore, & Vidyasagar Teachers' Training College is situated.

Role of the Institution (First Party):

- (i). The INSTITUTION shall provide the available infrastructure & basic amenities such as Computer, electricity, water, etc.; suitable and ready for delivering the training courses
- (ii). The INSTITUTION shall provide a workable space, room with basic amenities for the staff for successful outcome of joint activities.
- (iii). The INSTITUTION shall nominate a coordinator as a point of contact for Associate for proper operation of MoU.

Steering Committee

The MoU Provisions for constitution of a steering Committee with the following constitution with a view to operate the agreement quite meaningfully and successfully:

Notices

Unless otherwise provided herein, all notices or other communications under or in connection with this MoU shall be given in writing and may be sent by personal delivery or post or courier or facsimile. Any such notice or other communication will be deemed to be effective if sent by personal delivery, when delivered, if sent by post, two days after being deposited in the post and if sent by courier, one day after being deposited with the courier if sent by facsimile when sent (on receipt of a confirmation to the correct facsimile number).

Arbitration

- In the event of a dispute between the Global Academy and the VTTC arising out of, or relating to this Agreement, its interpretation or performance here under, the parties shall exert their best efforts to resolve the dispute amicably through negotiations.
- In case of any disagreement and dispute and the parties fail to mutually resolve the issue; both parties shall appoint an Arbitrator that is mutually agreeable and shall be settled as per Indian Arbitration Act.
